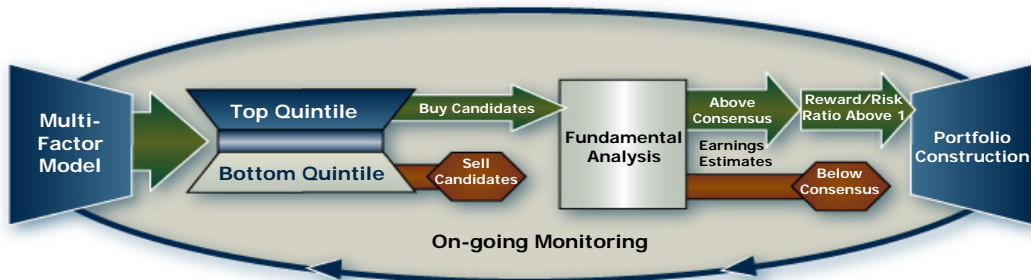
INVESTMENT PHILOSOPHY

- The ability to exceed consensus earnings estimates
- Stable to improving fundamentals
- Attractive valuations

INVESTMENT PROCESS

Our investment process: a rules-based process focused on positive earnings surprise.



1. Multi-Factor Model

- Stability of earnings
- Growth factors
- Value factors

2. Fundamental Analysis

- Above consensus proprietary earnings estimates
- Key merits and risks
- High/low price targets
- Reward/risk ratios above one

3. Portfolio Construction

- Reward/risk context
- Risk model tool
- Tracking error
- Sector and security constraints
- Indicated to beat or miss tool

4. On-going Monitoring

- Multi-factor model run daily
- Weekly portfolio and holdings review
- Stocks re-evaluated as earnings are reported
- Strict sell discipline

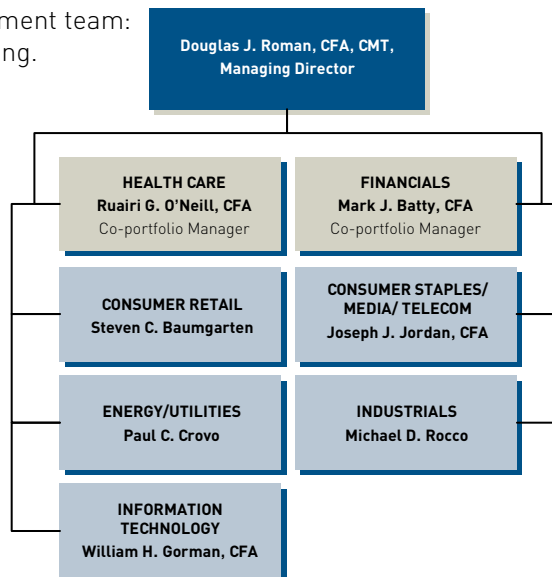

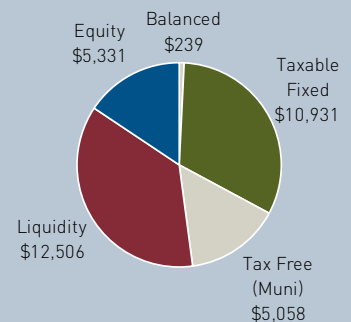
TEAM
